Dear Sir:-

The extension of time granted by the last legislature on personal property taxes expired on September 15th, 1933. The Assessor has again placed a Warrent of Distrain in my hands for service. This has to be paid before October 31st, 1933, or I will have to attach and sell sufficient property to cover the same. I have no other alternative as the law holds me liable in double the amount of taxes if I fail to act.

Your tax is now \$11.77 including a seventy cent cost of Warrent of Distrain. There are no Sheriff's costs to date, but should we be forced to attach and sell there Would be the added cost of mileage at twenty cents per mile, both to post and sell in addition to the notices, which would run your tax up to about three times what they are now.

So kindly give this your immediate attention and avoid the extra costs.
