## REGISTER AT HERMANS STORE 2 DAYS FOR CANNING SUGAR

Canning sugar certificates will be issues Saturday and Monday at Herman's store, according to latest information obtained by Mrs. W. M. Herman, chairman of the local sugar rationing board. Registration hours will be from 9 a.m. to 5 p.m. Mrs. Herman will be assisted by Miss. Esther Martinson, Mrs. Forrest Durbin, Mrs. Art Springer, Mrs. Ben Cook, Mrs. Mahlon Follett and Mrs. E. W. Vanouck.

Before proceeding further, it is absolutely necessary that you present your Sugar Ration Book Number before a certificate may be issued. When you have obtained your canning sugar certificate you may immediately purchase the amount of sugar allowed. This is the latest information Mrs. Herman has obtained.

According to instructions residents of the entire Genesee community, except those living in Rimrock, may secure canning sugar certificates at the Herman store Saturday and Monday, while it is understood that all people living in Nez Perce must report at the sugar rationing board in Lewiston. When original sugar ration books were issued people of Rimrock were permitted to obtain books at Genesee, but so far no advice has been received here of a similar procedure for obtaining canning sugar certificates.

The allowance is: One pound of sugar for each 4 quarts of fruit to be canned, with a maximum of 50 quarts of fruit per person. An allowance of one pound of sugar per person is made for jams and jellies. This is in addition to regular allowances, but where a person has such an amount of sugar on hand that purchases are not as yet permitted, then. The amount of sugar on hand will determine how much one may purchase for canning.

### **Questions to be Asked**

Following are the questions which will determine how much sugar an individual or family may purchase:

1. Name of family
2. Address of family
3. Name of individual making application
4. Address
5. Amount of sugar applied for (1 pound for every four quarts of finished canned fruit is the maximum allowed)

6. Have you registered for your regular war rationing book? (if not, the application will not be accepted until after you have registered.)
7. Did you receive a war ration book
8. What is its number? What are the numbers of the war ration books in your family units?
9. Number in family (if application is made for a family unit,) adults and children under 18.
10. How many quarts of fruit did you can last year? (This does not include preserves, jellies, fruit, butters and so forth.)
11. How many quarts of canned fruit which you put up do you have left from your last year's supply?
12. Over what period do you expect to use the fruit canned by you this season? (Six months, one year?)
13. Did you have excess sugar in your possession when you registered? How much? Do you have excess sugar in your possession now? How much?
14. Do you buy your fruit for canning or grow it yourself?
15. Do you sell any of the fruit you can?
16. Have you already applied for sugar for canning? How much were you granted on any previous application or applications for canning or preserving?
17. What approximate proportion of your canning for the entire year 1942 does this application cover?
